MUNICIPAL STREET LIGHTING SERVICE (L-1)**



AVAILABILITY

To lighting service required by any Municipality contracting for street lighting service for streets, alleys and other public ways. Not applicable to temporary, resale, shared, or seasonal service. For purposes of this rate schedule only the term "municipality" shall mean any incorporated city or town served by NLRE; or any unincorporated community where NLRE serves or where an incorporated property owners association or Board, as a part of its ordinary function, furnishes street lighting and other services normally provided by incorporated cities to, or for, residents of the unincorporated community.

CHARACTER OF SERVICE

Lighting service under this Schedule will be furnished from dusk until dawn. The service voltage and type of service, series or multiple, will be at the Department's option.

NET MONTHLY RATE

Department Owned Facilities

The following net monthly rate is applicable when the Department owns the entire street lighting facility, consisting of the Department's standard luminaire fixture on a wood pole, overhead circuits, controls and all other related equipment. Department will operate and maintain such facility at its expense, except that Municipality will reimburse Department for the cost of material required for replacing broken outer globes and for the total cost of replacing or repairing broken or damaged poles used primarily for street lighting.

ALL NIGHT OUTDOOR LIGHTING SERVICE (L-4)**



AVAILABILITY

To unmetered automatically controlled outdoor lighting service burning all night. Department will install, own, operate, and maintain Nightwatcher or Floodlight, including any necessary bulb replacements. All necessary normal service, maintenance and bulb replacements will be furnished at Department's expense after notice is given by customer. The cost of unusual maintenance resulting from vandalism shall be the responsibility of and billed to customer. If payment for such unusual maintenance is not made within the time period allowed in the Payment provision of this Rate Schedule the Agreement for All Night Outdoor Lighting Service shall be terminated and Department's facilities will be removed.

Not applicable for seasonal service. Applicable to temporary service when the Customer pays in advance of construction the estimated gross cost of providing, installing and removing the temporary facilities required to provide service less the estimated salvage value of such facilities upon removal.

CHARACTER OF SERVICE

Lighting service under this Schedule will be furnished from dusk until dawn. The service voltage and type of service, series or multiple, will be at the Department's option.
